REPORTS TO: Music Librarian

POSITION OVERVIEW: The Library Assistant reports to and assists the Music Librarian, as needed, with the administrative responsibilities outlined below in support of The New York Pops Music Library. This position is part-time and does not include rehearsal or performance duties.

DUTIES AND RESPONSIBILITIES:

- Preparation of parts including marking of bowings, cuts, edits, page-turns, and inserts
- Scanning, printing, and binding scores and parts
- Breaking down concert folders and filing orchestra sets
- Data entry for library elements within the catalog and additional general record keeping and cataloging
- Supports delivery of music to conductor, guest artists, and orchestra musicians
- Other duties as assigned or apparent

QUALIFICATIONS:

- At least 200 hours of prior performance library experience (i.e., 2 years of part-time work)
- Musical performance background; basic knowledge of music theory, history, and terminology
- Excellent communication skills. The successful candidate will possess an instinct for perfection and an infallible commitment to following instructions and asking clarifying questions.
- Exceptional organizational and time management skills; exemplary attention to detail; ability to work efficiently and meet deadlines
- Work well independently and as part of a team.
- Excellent computer skills including proficiency in Microsoft Office Suite.

- Must be available to work evenings and weekends
